







Message from the Principal

I am pleased to present the Makerere University School of Law (SoL) Annual Report for 2022 which highlights some of our major activities and challenges. The report documents steps the School has taken to realise our vision and mission in light of Makerere University's strategy of strengthening graduate training and becoming a research-led University. The School actively participated in the Makerere@100 celebrations, hosting conferences and seminars. The SoL has registered several developments, among which is the award of the first doctoral degree to a female, Dr. Caroline Adoch at the 72nd Graduation of Makerere University.

We have developed two new specialized demand-driven Master of Laws degree Programmes, i.e. Master of Laws in Human Rights Law and Practice and Master of Laws in



Corporate and Commercial Law. The two programmes were approved by the University Senate and now await approval by the Directorate of Quality Assurance before submission to National Council for Higher Education (NCHE) for accreditation. Developing new demand-driven graduate programmes is important more especially now when Makerere is shifting focus to graduate training and becoming a research-led institution of higher learning.

The School continues to cultivate new partnerships to support our work. S&L Advocates (formerly Sebalu & Lule Advocates) donated a full set of All England Law Reports (1936-2020) to the School of Law (SoL), Makerere University. The law reports will greatly support teaching and learning. Afya na Haki (AHAKI) handed over Thirty-Nine (39) Million Uganda Shillings to support production of a Special Issue of the East African Journal of Peace and Human Rights (EAJPHR); the special issue scheduled for release in October 2022 covers Sexual and Reproductive Health Rights (SRHR).

SoL takes pride in providing different opportunities for our learners, including participation in Moot Competitions at national, regional and international levels. The School of Law excelled at various moot competitions in 2022; The Makerere University School of Law (SoL) team (Ms. Kevin Nakimbugwe and Mr. Edwin Sabiti) are reigning champions of the *All Africa Human Rights Moot Competition* held in July 2022 in Cairo, Egypt. SoL students also excelled at the Inaugural Arbitration Moot competition held in Nairobi, Kenya, November 2022; organised by Chartered Institute of Arbitrators – Kenya Chapter. Our students also won the Inaugural Tech Law Moot Court Competition held in October 2022 at Cavendish University, Kampala-Uganda. We also won the Constitutional Law Moot organised by the Centre for Health, Human Rights and Development (CEHURD) held in November, 2022.

I would like to thank the Government of Uganda, University Administration and development partners for their support of our activities during 2022. I also extend thanks to administration at the SoL, staff and students for participating in the activities of the School.






Introduction

This report is a presentation of status and work of the Makerere University School of Law (SoL) for the year 2022. SoL is a trail-blazer in the arena of legal education and training. It has well trained and experienced academics who impart quality legal knowledge and skills within an inter-disciplinary framework.

Structure of the School of Law

The School of Law is run under a three-tier collegiate system i.e., the University, School of Law, and the constituent departments. The School has five departments i.e., the Department of Law & Jurisprudence, Public & Comparative Law Department, Commercial Law Department, HURIPEC and the Environmental Law Centre (ELC).



Outreach, Research and Advocacy Centres/Initiatives

SoL has six Outreach, Research and Advocacy Centres/Initiatives through which we conduct outreach, research and advocacy.

The Human Rights and Peace Center (HURIPEC)

HURIPEC is a semi-autonomous department under the School of Law established by Makerere University in 1993, as the first human rights center of its kind in Sub-Saharan Africa. Although several human rights-related subjects were already being taught at the Faculty of Law, HURIPEC was established solely to foster on teaching, research and activism on human rights and peace issues at the University. Since that time, not only has the number of subjects in the area expanded considerably, also the range of activities being pursued.

The centre pursues a vision of contributing to the establishment of a human rights conscientized, educated, activist, academic society in Uganda and countries yonder. It seeks and has consistently engaged in events geared at promoting the understanding and respect for human rights, democratic governance and sustainable peace in the East Africa sub-region specifically and Africa generally through teaching, research, policy and advocacy.

The Public Interest Law Clinic (PILAC)

The Makerere University School of Law Public Interest Law Clinic was established in January 2012, becoming the first Clinic established at a University in Uganda. PILAC seeks to promote hands-on experiential learning as well as exposing students to 'live' cases of individuals who have been confronted by the law in its varied manifestations. PILAC has established a Clinical Legal Education (CLE) programme, which is hands-on learning programme, intended to equip law students with public interest lawyering skills. The Public Interest Law Clinic seeks to promote a culture of social justice lawyering in Uganda by developing a consciousness amongst law students of the important role public interest lawyering plays in protecting the rights of ordinary Ugandans.

To this end, the clinic trains students in strategic use of the law, including the use of national and regional mechanisms, to protect human rights, the public interest and promote social justice, while at the same time providing law students with the requisite legal skills, training and practical experience to become effective legal professionals. The CLE programme aims to train law students to fulfill their civic duties to the public on a long-term basis and contribute to cultivating a new generation of advocates fully equipped and committed to promoting the public interest and social justice as part of their civic duties

The Center for Law and Emerging Technologies (CLET)

CLET was established in 2019 as an initiative for the Department of Law and Jurisprudence. It was set up to provide legal and policy solutions for the responsible adoption of the 4th Industrial Revolution (4IR) technologies. The new and emerging technologies and various scientific advancements are constantly giving rise to new issues in law, governance, and

ethics. These issues need to be researched and debated upon in a constructive and informed manner if solutions are to be found that promote the public interest, accountability, legitimacy, social equity, and inclusion. CLET seeks to provide a platform for such research and debate. Since emerging technologies present unique opportunities for Uganda; for example, ensuring transparency, accountability, legitimacy, and social control, which are key for efficient service delivery in the country, there is a need to assess and realign the legal and policy framework to ensure that there are sufficient protections to harness the benefits of these technologies, while mitigating the attendant risks. With funding from the Government of Uganda under the Research and Innovation Fund, CLET is undertaking research about how emerging technologies can enhance public service efficiency and accountability to transform public service delivery. The project seeks to promote highquality interdisciplinary research, teaching, and engagements to discover approaches through which the law can facilitate the responsible use of emerging technologies to ensure efficient service delivery to the public. The project involved field work through Interviews are being conducted with different stakeholders such as Government agencies, ministries, registration services, financial institutions and private entities working in the area of emerging technologies to establish knowledge, gaps, challenges and opportunities for improvement. This will culminate into the production of a report. The Center is also set to conduct capacity building trainings for academics and public servants on the opportunities that emerging technologies present. In addition to this, it is undertaking career mentor facilitation for law students interested in emerging technologies and has supervised students on different research topics around 4IR technologies for their 4th year research papers.

The Refugee Law Project

The Refugee Law Project is a community outreach project of the School of Law, Makerere University. The project empowers asylum seekers, refugees, deportees, IDPs and hosts communities to enjoy their human rights and lead dignified lives.

The project is mandated to 1) Promote the protection, well-being and dignity of forced migrants and their hosts; 2) Empower forced migrants, communities and all associated actors to challenge and combat injustices in policy, law and practice; 3) Influence national and international debate on matters of forced migration, justice and peace and 4) Serve as a resource for forced migrants and relevant actors.

The Business Law Clinic (BLC)

The Business Law Clinic (BLC) established in 2019, started out as a three year Pilot project of the Department of Commercial Law with funding through the Makerere University Research and Innovations Fund (RIF I) under the name 'Transactional Law Clinic' Pilot Project. The overall objective of the Clinic is to enhance the relevance of legal education and practice in addressing the legal needs of indigent persons, low-income earners, and not-for-profit business ventures. The Clinic is founded on the notion that enhancing access to transactional legal services empowers communities and facilitates inclusive and sustainable development for Uganda. The BLC is also designed as an innovation to expand the use of clinical methods in legal education. Through experiential learning law students tackle issues of economic rights and economic development for community organisations, especially those which cannot afford transactional legal services. In 2019-2020, the Clinic enrolled 12 students. In 2021, the Clinical Curriculum was improved and disseminated. It is

hoped that after dissemination, it will be adopted as a means of improving the teaching of commercial law subjects in the different Universities teaching law in the country. In 2022, the BLC was awarded funding under RIF III for the period January-June 2022. The BLC has enrolled a second cohort of 14 students.

Disability Law and Rights Centre

The overall objective of Disability Law and Rights Centre (DLRC) is to contribute to changing the legal profession in Uganda from one less committed to and aware of the needs of persons with disabilities (PWDs) to one which is skilled and prepared to address the legal and human rights needs of PWDs. This will be achieved by influencing reforms in legal education which is expected to result into law graduates and eventually a judicial system which is committed and skilled to promote and protect the legal rights and needs of PWDs.

This is to be achieved through review, development and change of curriculum to integrate disability issues into the different modules; enhance the skills of staff at the School of Law, as well as for the rest of Makerere University to engage disability lens in the teaching and conduct of their work; raising awareness of disability rights across the university and encourage and support disability-friendly interventions for learners with disabilities; conducting research on topical issues concerning disability rights, law and policy; developing teaching materials in the area; collaborating and networking with Disabled People's Organisations (DPOs), government 53 ministries, departments and agencies as well as other stakeholders to promote the protection and realisation of the rights of persons with disabilities.



Teaching and Learning

Teaching law and producing legal professionals well equipped to address new and emerging legal challenges at the national, regional and international levels is the core mandate of the School of the Law.

The School runs three mainstream programmes: The Bachelor of Laws degree programme, the Master of Laws degree programme and the Doctor of Laws degree programme. In addition to these three programmes, the School runs several short-courses including its flagship Administrative Law Short-Course for mainly public servants.

The School has developed two new specialized demand-driven Master of Laws degree Programmes. These are the Master of Laws in Human Rights Law and Practice and Master of Laws in Corporate and Commercial Law. The two programmes were approved by the University Senate and now await approval by the Directorate of Quality Assurance before submission to National Council for Higher Education (NCHE) for accreditation. Developing new demand-driven graduate programmes is important more especially now when Makerere is shifting focus to graduate training and becoming a research-led institution of higher learning.

Makerere University' 72nd Graduation

The School of Law presented graduands on the first day of Makerere University's 72nd Graduation Ceremony held on the 23rd May 2022 at the Freedom Square, Makerere University. A total of 207 graduands were presented by the School including (1) Doctor of Laws, (18) Master of Laws and (188) Bachelor of Laws.

A Doctor of Laws degree (LL. D) was awarded to Caroline Adoch making her the first female to get an LL. D of Makerere University. Dr. Adoch's LL.D thesis is titled: Access to Gender Justice in Uganda: A Feminist Analysis of the Experiences of Rape Victims in the Reporting and Prosecution Processes. She was supervised by Professor Sylvia Tamale and Professor Christopher Mbazira.

Master of Laws degrees were awarded to 9 females and 9 males while the Bachelor of Laws degree awardees were 70 females and 118 males.

LLM / MPHIL in Human Rights and Democratization Program 2022

In 2022, The School of Law (SoL), Makerere University hosted two students namely; Ms. Christine Zanele Fengu from South Africa and Ms. Florence Otieno Achieng from Kenya under its LLM/ MPhil Human Rights and Democratization program (HRDA) partnership.

The SoL has for the last 22years been partnering with a number of Universities across Africa on the LLM/ MPhil Human Rights and Democratization program (HRDA). Every year the program offers up to 30 scholarships to top students from across Africa interested in doing the LLM/ MPhil Human Rights and Democratization program (HRDA). Students admitted on the program are expected to undertake the first 8 months of the program at the University of Pretoria, and four months at one of the selected partner Universities. While at the partner University, the students are expected to finalize their research dissertations and also carry out a four months' internship with a reputable Human Rights organization.

Ms. Fengu' research was titled 'Effectiveness of Refugee Laws on Child Statelessness (A Comparative Analysis of South Africa and Uganda)'. She was attached to the Refugee Law Project and supervised by Dr. Maria Nassali, SoL / Prof. Magnus Killander, University of Pretoria.

Ms. Achieng' research was titled 'For Public Interest: Strategic Litigation as a tool to realize the right to Education in East Africa: A Case Study of Uganda'. She was attached to the Initiative for Social Economic Rights (ISER) and was supervised by Prof. Christopher Mbazira, SoL and Dr. Faranaaz Veriava, University of Pretoria



Highlights of Events and Activities for 2022

The College undertook various activities and hosted events throughout the year, we share highlights.

High Level Delegation from East African Court of Justice visit Mak School of Law

On 30th November 2022, a delegation of Honourable Justices of the East African Court of Justice (EACJ) visited Makerere University School of Law to engage academia and students in promoting Justice in the East African Community Integration Agenda.

The visiting delegation was led by Hon. Justice Nestor Kayobera – Judge President of the EACJ together with Hon. Justice Kathurima M'Inoti - Judge EACJ Appellate Division, Hon. Justice Cheborion Barishaki - Judge EACJ Appellate Division; Hon. Justice Yohane Masara - Principal Judge EACJ, Hon. Justice Dr. Charles Nyawello -Deputy Principal Judge EACJ, Hon Justice Richard Wabwire Wejuli - Judge EACJ First Instance Division and Her Worship Christine Mutimura Wekesa - Deputy Registrar EACJ.

The EACJ delegation was accompanied by members from the Judiciary of Uganda i.e., Hon. Lady Justice Anne Mugenyi - Deputy Head of Commercial Division High Court Uganda, Her Worship Juliet Hatanga - Deputy Registrar Commercial Division High Court Uganda, and Her Worship Juliet Nakitende - Assistant Registrar Commercial Division High Court Uganda.

The EACJ delegation were received by the Leadership of the School of Law led by the Principal - Assoc. Professor Ronald Naluwairo and Deputy Principal, Dr. Zahara Nampewo. – They were led on a tour of an exhibition of material produced by research centres at the School of Law. The delegation proceeded to the School Auditorium to engage students.

New Leadership at School of Law: Handover Ceremony

Professor Christopher Mbazira handed over office to Dr. Ronald Naluwairo (Assoc. Professor), the incoming Ag. Principal, School of Law, Makerere University at a ceremony held on Monday, 20th November 2022 at the School of Law premises. Professor Mbazira had served as Ag. Principal of the School of Law since June, 2016 until 14th November, 2022 when Dr. Naluwairo was appointed. Dr. Naluwairo also handed over office to the new Ag. Deputy Principal, Dr. Zahara Nampewo.

Presenting his handover report, Professor Mbazira highlighted the achievements of the School of Law during his term of office:

- The LLB Curriculum has been reviewed by the School and awaits submission for accreditation by the University Management to the National Council for Higher Education. Specialised LLM programmes i.e., Human Rights and Commercial Law programmes have been adopted by the School and await approval by Senate.
- Entrenchment of the Clinical Legal Education (CLE) methodology for all courses at the School of Law
- Giving School visibility and relevance in the community
- Celebrating 50th Anniversary of the School of Law in 2018
- Lobbying for a new administrative block for the School which is under construction and expected to be opened in early 2023
- Improving the relationship between faculty and administrative staff.
- Building partnership with key stakeholders, including the Judiciary and Alumni.
- Conducting the LLB Pre-entry examinations with credibility.

A number of challenges were also highlighted: Inadequate funding with progressively declining budget; Staff deficiencies, arising from inadequate number of staff; Over reliance on development partners for project activities; Dilapidated infrastructure; Lack of automation of administrative functions; Transport gaps, the School van is old and replacement required; and the COVID-19 pandemic lockdown.

The new Principal, Dr. Naluwairo thanked Professor Mbazira for the service to SoL and commended him for the consultative leadership. He promised to build on the achievements realised by the outgoing Principal to take the School to greater heights.

Achievements highlighted while Dr. Naluwairo served as Deputy Principal included:

- Improving the graduation rates of LL.M students from an average of 6 to 20 per year in the last 6 years;
- Leadership on the review of the LLB curriculum;
- Overseeing and providing leadership in the development of two new specialized LLM Programmes;
- Chairperson of the team that successfully developed the School of Law Strategic Plan 2020/21 -2029/30

PILAC Celebrated 10 Years

On the 17th November 2022, the Public Interest Law Clinic (PILAC), School of Law, Makerere University concluded their 10 years' celebration of existence with a conference. The celebration and conference were themed 'Consolidating our gains through Transforming Legal Education, Promoting Public Interest Litigation, Enhancing Access to Justice and Leveraging on Strategic Partnerships'.

Established in 2012 as the first legal Clinic at a University in Uganda, PILAC has been instrumental in transforming the teaching of legal education and legal practice through its experiential learning, strategic litigation strategies through exposure of students to 'live' cases of individuals who have been confronted by the law in its varied manifestations. PILAC's interventions have benefited about 600 students, over 1000 vulnerable clients and over 200 legal practitioners.

The conference was officially opened by Associate Professor Umar Kakumba, Deputy Vice Chancellor – Academic Affairs, Makerere University. Associate Professor Kakumba challenged PILAC that he hopes, 'when we return to celebrate 20 years of PILAC in 2032, there will be stories of transformative education in the graduate programmes at the School of Law; the big consideration for you is how the CLE model can be infused into the LLM programme'.

In his keynote address, Professor Christopher Mbazira, Coordinator PILAC explained that the idea of Clinical Legal Education (CLE) was borrowed from medical schools. This allowed exposing lawyers to social and psychological setting of cases handled; historically CLE was first embraced in the US Law Schools with reservations.

Professor Mbazira highlighted that PILAC has impacted the LLB programme through revision of the curriculum, the teaching methodology and interface with the community. He noted that the impact has also benefited Law Schools in Uganda and the region, rather than compete, the schools resolved to work together; an association bringing together clinics at Law Schools has been formed i.e., East African Network of University Law Clinics (EANULAC).

The Makerere University School of Law team won the 2022 Christof Heyns African Human Rights Moot Court Competition

The SoL team (Ms. Kevin Nakimbugwe and Mr. Edwin Sabiti) won the 2022 edition of the Christof Heyns African Human Rights Moot Court Competition. The Moot Competition held from the 25th – 30th July in Cairo, Egypt was hosted by The British University in Egypt. The All Africa Moot Competition is named after Professor Christof Heyns (1959-2021) who was a Professor of Human Rights Law, Director of the Institute for International and Comparative Law in Africa at the University of Pretoria and a member of the United Nations Human Rights Committee. The 2022 edition attracted a total of 50 Law Schools, 38 of these were English speakers.



Advocacy

Transparency and Accountability (TACOR) project

HURIPEC carried out several activities under its Transparency and Accountability (TACOR) project. This project aims to contribute towards enforcement of transparency and accountability mechanisms of COVID resources by strengthening Parliament as an engine for democratic transformation and accountability. We have engaged various partners including parliamentarians, civil society, district leadership and the media, inter alia. The project is focussed on the regions of Uganda – northern, eastern, western and central. The following are highlights of activities under this project:

Security Peace and Development: Research and Advocacy

In line with its mandate on advocacy and awareness raising, HURIPEC published an article in the New Vision Newspaper for the International Peace Day, on 21st September 2022. The article emphasized the need to recognise the life and inherent dignity of all Ugandans as necessary for durable peace.

Recognising the life and inherent dignity of all Ugandans is necessary for pathways to durable peace.

To day is Peace Day, Ugandans have faced insurmountable levels of violence tracing back to the precolonial to colonial and post-colonial times. An increasing number of studies in epigenetics and sociology support the idea that generational trauma can be passed down through epochs of time and even affect entire communities or nations, including holding them bonded to low self-worth and indignity. As Ugandans our healing from violent pasts will involve learning about these pasts in more honest, objective, deeper and intimate ways than we have been taught in school, understanding the many ways in which these experiences affected our predecessors and tracing how they show up in our present reality. This holistic approach can lead us to more compassion for each other and to new ways of seeing and acknowledging each other's 'dignity regardless of where we come from. It would lead us to a more collective consciousness that these pasts should not be repeated or sustained and that we all owe each other a duty to heal as a nation. This is a powerful safeguard against violent conflict as it transcends many of the limitations we put on our humanity as Ugandans.

To this end, it is necessary that Ugandans continue to reject any and all ideologies that seek to instil and entrench feelings of worthlessness or indignity including suggestions that victims of violence including police violence or security forces' excessive force, torture, inhumane and degrading treatment, disappearances, among other such violations deserve what they get, or that violence is the "only language they understand" or suggestions that fifty or one hundred victims of such violence is no cause for concern. These are perspectives starkly commensurate with the colonial times where Ugandans were regarded by a foreign colonising force as subhuman, and are a reflection of the collective trauma from state violence passed down through that turbulent history into the present day. We can and must extricate ourselves from this past. To remain silent would be to acquiesce to dictations of our worthlessness and indignity. Many scholars of the subject agree that inaction including on the part of victims of violence—be it state violence, intimate partner violence, or structured violence—be it state violence, intimate partner violence, or structured violence—be it state violence however minimal is necessary to reaffirm to oneself and assert to one's violator, one's sense humanity, self-worth and dignity. To this end, calls should continue for the investigation and prosecution of unlawful killings perpetrated through the use of excessive force by Ugandan security

forces during the November riots, the walk to work protests, the 2016 violence in Kasese, the Apaa land conflict and violent disarmament in Karamoja, among other such recorded excesses.

The necessary work of our healing would also require a varied array of actors including academia, media, civil society, security forces, and religious leaders, among others. A multidisciplinary approach from academia would especially be insightful with historians, lawyers, anthropologists, philosophers, sociologists, psychologists among other disciplines informing robust dialogue and debate with emotional intelligence, publications and dissemination on the question of violence in Uganda and pathways to dignity and durable peace. Lawyers have some very foundational work to do relating to reform and clarification of the law particularly as it relates to the use of force by state security forces as one of the main legacies of violence at a macro level. Here is it important to reassert that the law on the use of force by security actors in Uganda is grounded in the preservation of the right to life which is accorded an especially high threshold of protection under the 1995 Constitution. Moreover colonial standards that have purported to indemnify the police for deaths or harm arising from excessive use of force have been struck down by the Constitutional Court in Moses Mwandha versus Attorney General Constitutional Petition No. 5 of 2007. Lawyers should explore ways in which these adjudicated decisions and principles can be implemented through law reform and how similar old colonial laws which bear the blue print for our collective maltreatment and indignity are expunged from the standards which govern human life in Ugandas. With such expunging, we can inscribe new standards on how the state can apply force to implement the mandate given to it to maintain law and order without abusing its power and while protecting human life and dignity, which is inherent in all Ugandans.

Finally, for our reflection on this Peace: As part of a global black collective which continues to experience some of the most extreme forms of violence across the world, how can we continue to demand for dignity when we cannot accord it to ourselves within our own local domains of power and control?

Special Issue of the East African Journal of Peace and Human Rights (EAJPHR)

In collaboration with AHAKI, a leading African institute that generates knowledge and builds advocacy capacities in health, human rights and sexual reproductive health and rights using Africentric approaches, HURIPEC initiated a process for a special issue of the East African Journal of Peace and Human Rights. This issue was part of the Mak@100 celebrations with focus on issues of sexual and gender-based violence and sexual and reproductive health rights from an Afri-centricism lens. These issues have been particularly key during this Covid19 period and yet have hitherto been eclipsed from overt academic attention. The journal will flag these critical issues through an academic engagement. The event took place on 13 July 2022 at the School of Law Board room at which AHAKI presented a cheque of Ushs. 39 million to facilitate this process. The cheque was received by the Vice Chancellor Prof. Barnabas Nawangwe on behalf of the HURIPEC and Makerere University.

Militarisation, Sustainable Growth and Peace in Uganda Project

This is a collaborative research project between The Human Rights and Peace Center (HURIPEC) of the School of Law, Makerere University in Uganda and The Centre for Resolution of International Conflicts (CRIC) at the University of Copenhagen, Denmark with the support of the Ministry of Foreign Affairs of Denmark.

The project team includes Associate Professor Ronald Naluwairo, Professor Christopher Mbazira, Professor Joe Oloka-Onyango, Dr. Zahara Nampewo, Dr. Sylvie Namwase, Mr. Jackson Odong, Mr. Derek Scottman, Ms. Mathilde Kaalund, Mr. James Nkuubi and Mr. Ole Waever.

The overall goal of the project is to contribute to enhancing knowledge and understanding and to capacitate both Ugandan actors and international partners in contributing to overarching Sustainable Development Goal (SDG) No. 16 on Peace, Justice, inclusive growth and Strong Institutions as it relates to the widening role of Uganda's security sector in development. This project therefore seeks to examine the nature and extent of security actors' involvement in Uganda's key sectors and institutions and the ways this process impacts central development agendas, possibilities for oversight, institutional capacities and independence.

The project provides a full scholarship and stipend to two PhD Students, one from Uganda and the other from Denmark, and a fully funded 6 months stay in Denmark for the Ugandan PhD. The Ugandan PhD is in advanced stages of thesis write up and is expected to defend his PhD by the end of June 2023.

The project is in the final stages of an edited book volume under a tentative title: *Militarising more to develop faster? Uganda's difficult choices on governance, human rights and economy.* The book has ten chapters including the introduction and conclusion. A special journal issue and a report on the key project themes are also in final stages of getting published. A series of academic podcasts exploring broader global themes on securitization and militarisation are also planned for 2023.

Collaboration with University of Copenhagen


Dr. Zahara Nampewo and Dr. Sylvie Namwase were hosted by the Centre for Resolution of International Conflicts (CRIC) at the University of Copenhagen (UoC, Department of Political Science between the 11th and 13th October 2022in Denmark to speak on preliminary findings from a joint project between HURIPEC and CRIC. The two institutions are collaborating on research about the role of Uganda's security sector in national development and peace.

While at the UoC, Dr. Zahara was also hosted at the School of Law, where she made a special presentation on the migration patterns into and out of Uganda with specific focus on labour externalization from Uganda to the Middle East.
