### **Message from the Principal**

am delighted to present to you the Makerere University School of Law 2023 Annual report. The report highlights the major activities undertaken and the major outputs in light of our core mandate of teaching, research and community outreach. It also highlights the challenges the School is facing and future plans.

With respect to teaching and learning, we successfully implemented all the scheduled activities including teaching, examinations, orientation for new freshers, field attachment, graduate admission exams and graduation. At the 73rd graduation ceremony of Makerere University, the School presented a total of 249 graduands of which 23 were awarded Master of Laws degrees and 226 awarded Bachelor of Laws degrees. To make our graduate programmes more relevant and competitive, we revised the Master of Laws programme and the Doctor of Laws programme. Additional to these revised programmes, in the course



of next year, we expect to launch two new specialized Master of Laws degree programmes which are currently before the National Council for Higher Education for accreditation.

Students' participation in moot court competitions is one of the major methodologies we employ in teaching our learners. Besides the learning, participation in moot competitions gives our learners exposure and provides them great opportunities for net-working. I am happy to report that in 2023, our students excelled in all the national and international moot court competitions they participated in. They won the Phillip Jessup International Moot Court Competitions national rounds and were supposed to represent Uganda at the international rounds but failed to secure visas in time. Our students also won the inaugural Gender and the Law moot competition. We emerged first runners-up in the Great Lakes International Humanitarian Law moot court competitions.

In the area of research, our faculty undertook a number of research projects and published many scholarly journal articles, books and reports on different subjects. I congratulate them for these research out puts. Among our major research outputs for 2023 is the edited book volume on Militarization and Development in Uganda. This publication unravels how militarization is taking place in the different sectors, the implications, and the hard choices Uganda has to make with respect to governance, human rights and economic development.

With respect to community outreach, our faculty and students participated in a number of initiatives and activities that were undertaken by our different units in particular, the Public Interest Law Clinic (PILAC), the Refugee Law Project (RLP) and the Human Rights and Peace Centre (HURIPEC). Among these include: training of University staff and other stakeholders on refugee rights and duties; training of police officers on disability rights and the law; legal aid camp for students and staff of Makerere University; participation in the Uganda Law Society (ULS) probono day; and conducting the Administrative Law short course in various parts of the country. In addition to providing learning opportunities to students who participate in them, our community outreach activities are very important for making our School more relevant in terms of empowering the local communities and addressing some of their legal-related challenges and needs.

I thank the Government of Uganda, Makerere University Council, Makerere University Top Administration and all our partners and well-wishers for your support that enabled us to implement numerous activities and achieve the highlighted outputs. I also thank colleagues in the administration at our School, staff and students for participating in the different activities.



### **About the School of Law**

#### Structure of the School of Law

The School of Law is one of the 10 colleges of Makerere University. The school is run under a three-tier collegiate system i.e., the University, School of Law, and the constituent departments.



The School has five departments i.e., the Department of Law & Jurisprudence, Public & Comparative Law Department, Commercial Law Department, Human Rights & Peace Centre (HURIPEC) and the Environmental Law Centre (ELC).

In addition to the five departments, the school has ongoing research initiatives in the different departments and Centres through which staff and student realise research output, engage communities and convene stakeholders to discuss important developments. The Human Rights and Peace Center (HURIPEC) is a semi-autonomous department under the SoL as the first human rights center of its kind in Sub-Saharan Africa. The centre will celebrate 30 years later this year since establish. HURIPEC produces a journal titled East African Journal of Human Rights (EAJHR) with two issues each year, in June and November. The Public Interest Law Clinic (PILAC) established in 2012 celebrated 10 years in 2022; as the first Clinic established at a University in Uganda, PILAC seeks to promote hands-on experiential learning as well as exposing students to 'live' cases of individuals who have been confronted by the law in its varied manifestations through the Clinical Legal Education (CLE) programme, which is hands-on learning programme, intended to equip law students with public interest lawyering skills. Another initiative is the Center for Law and Emerging Technologies (CLET) established in 2019 as an initiative for the Department of Law and Jurisprudence. CLET provides legal and policy solutions for the responsible adoption of the 4th Industrial Revolution (4IR) technologies. The Business Law Clinic (BLC) established in 2019 works to enhance the relevance of legal education and practice in addressing the legal needs of indigent persons, low-income earners, and not-for-profit business ventures. The Disability Law and Rights Centre (DLRC) contributes to influencing reforms in legal education which is expected to result into law graduates and eventually a judicial system which is committed and skilled to promote and protect the legal rights and needs of PWDs.

# Teaching and Learning

The School runs three mainstream programmes: The Bachelor of Laws degree programme, the Master of Laws degree programme and the Doctor of Laws degree programme. In addition to these three programmes, the School runs short-courses including its flagship Administrative Officers's Law Short Course Programme for mainly public servants.

#### 2.1 Students Enrollment 2022/2023

The SoL registered a total enrollment of 1126 students, with 994 students at undergraduate level and 132 students at graduate level as presented in the table below.



## 2.3 Presentation of Graduates at Makerere University's 73<sup>rd</sup> Graduation Ceremony

### 2.5 Graduate Admission Test (GAT):

The GAT is a requirement for students that apply to study from LLM at SoL. The test was held on the 17<sup>th</sup> June 2023. A total of 189 applications for LLM in AY2023/2024 were received and sat for the test. A total of 91 candidates passed the GAT and were admitted to the LLM programme.

### 2.6 Freshers' Orientation 2023: Law Students given advice on how to excel

The first-year law students (Academic Year 2023/2024) were welcomed to Makerere University School of Law (SoL) at an orientation meeting held on the 22nd and 23rd August 2023. The students were advised to work hard and keep focused during their time at SoL.

The SoL invited eminent lawyers as guest speakers to the orientation to orient, motivate our LLBI students as well as share their experience in the profession. The guest speakers were Moses Okwalinga, CEO – Uganda Law Society; Andrew Kibaya, Partner – Shonubi, Musoke & Co. Advocates; and Lilian Byarugaba Adriko, CEO – FIDA Uganda.



In his remarks, Dr. Ronald Naluwairo (Associate Professor), Ag. Principal —SoL welcomed the students to Makerere University and the School of Law. He congratulated them on being the lucky 280 who passed the law pre-entry exam and admitted to the LLB programme. He pledged maximum support to the students to have an enriched study experience and completed their studies on time. He added, 'don't hesitate to ask for help, all staff are available to offer the required support because no one should fail'.

The Ag. Deputy Principal Dr. Zahara also welcome the students to Makerere University and SoL. She told the students that the law profession is one where networks are important and they should value the partnerships of SoL and those assembled here to speak to them.

Mr. Kibaya commended the students on choosing to study law, he said 'the course calls for self-motivation, a lot of reading and avoid pass degrees'. He added that students should be careful with what they share in this age of internet and social media which could affect their careers, where information about someone can be weaponized. He also recommended that students distinguish themselves through short courses, internship and voluntary service.

The CEO – FIDA Uganda, Ms. Lilian Byarugaba Adriko encouraged students to live intentionally, develop their vision boards and keep themselves informed through reading. She particularly advised the girls to be confident and form friendships for support and future networks. 'Live a responsible life, don't miss classes and keep time', she added. Ms. Adriko also explained that FIDA Uganda is working on establishing chapters at law schools and she looked forward to engaging and mentoring student lawyers.

Mr. Okwalinga reiterated the welcome message of the previous speakers noting that this is a start of a journey and advised students to stay focused for best results from law school. 'I hope you are inspired by the speakers here today, all of whom have experienced this journey. We look forward to you joining ULS when you eventually qualify', he said.







### 2.11 Administrative Officers' Law Short Course Programme

Alongside the three mainstream degree programmes, the SoL offers the Administrative Officers' Law Short Course leading to the award of a Certificate in Administrative Law. The duration of study is 2months and the minimum admission requirement is A 'Level certificate or its equivalent. This is recognized by the Public Service Commission for purposes of entry, confirmation and promotion of administrative cadres of staff. Training is conducted at Makerere University for the Kampala Centre and in a number of outreach stations in Arua, Jinja, Mukono, Tororo, Masaka, Hoima, Gulu, Lira, Mbale, Soroti, Luweero, Kiboga, Kiryandongo, Mbarara, Kabale, Rukungiri, Kyenjojo and Fort Portal.

### 2.13 FIDA Student Chapter launched at Mak School of Law

The first student chapter of the Uganda Association of Women Lawyers (FIDA) was launched at Makerere University School of Law (SoL) on 14th September 2023.

In her opening remarks, Dr. Zahara Nampewo – Ag. Principal, SoL welcomed FIDA(U) to SoL. She highlighted that this is an opportunity for female and male students to learn more about the work of FIDA(U). Dr. Nampewo encouraged students to be open minded and be willing to learn when they join FIDA. 'FIDA(U) has been a training ground for many young lawyers through research activities, internship and continuing legal education (CLE) points for practicing lawyers'. She further said, 'It is almost impossible to leave your mark as a woman lawyer without crossing paths with FIDA(U)', mentioning senior judges and advocates who served the organisation in the past. She highlighted faculty at SoL like Associate Professor Damalie Naggita Musoke who served as Board Chairperson for FIDA(U), Dr. Maria Nassali also serving on the board and many others who are registered members. Dr. Nampewo advised that FIDA(U) should work with SoL leadership for smooth governance and accountability.

Explaining why the chapter was launched, Ms. Patience Ayikoru – Membership Officer, FIDA(U) said, 'we wanted to start a students' chapter so that student lawyers can learn more about FIDA(U) as well as get access to the resources available to legal professionals which include: lectures and webinars, access to learning from experts like High and Supreme Court Justices through online and in-person learning and hands-on workshops and trainings'.

The Project Coordinator at FIDA(U), Ms. Deborah Okia noted that one of the aims for the FIDA(U) students' chapter is movement building which provides space to cultivate and mobilize human rights and access to justice initiatives. She said "Under movement building we have what we call creative action: the younger generation is very innovative and creative so we are looking to you to assist us. Then we have lobbying efforts which also require creativity to push our agendas forward'.

Associate Professor Naggita welcomed FIDA(U) to Makerere University and SoL. 'FIDA(U) has done a lot of work for vulnerable people and family. The work is not only for women but the wider society to access justice', she said. She encouraged the students to get involved in the multiple opportunities available in FIDA.

The Advocacy Manager of FIDA(U), Ms. Elizabeth Kemigisha highlighted the thematic areas of the organisation including; Access to Justice, Economic Justice and Advocacy. She expressed that she looks forward to engaging and working with the students in the various activities. 'We are not here to re-invent the wheel but support the work that Makerere Law Society does and more especially support better futures for women, children and wider society', she added. Ms. Kemigisha explained that registration with the student chapter is free, however an annual fee of 20,000Ushs is required to access activities. In addition, while female students are registered as members, the male students are categorized as 'friends of FIDA(U)' and they will also partake in the activities.

### 2.14 Student Voices and Experiences – Clinical Legal Education (CLE)

Joining the CLE class is a dream for Bachelor of Law (LLB) students at the Makerere University School of Law (SoL). As soon as students join Year III of the LLB programme, they are on the lookout for the call for applications and prepare for selection for those that are eventually lucky to join the CLE class. The selection process is very competitive and members who join look back on the experience with fond memories, having learned so much from the opportunities they access. As part of the experiential learning offered at Makerere University School of Law (SoL), our students are sent out on externships in legal settings including courts of law, police, prisons, remand homes among others where they get to see what happens in the real world of legal professional work. Selected voices from CLE Class of 2023 presented below:

Apica Angela Area, a student of CLE class 2023 said 'I am honoured to have been part of the team going to Mengo Chief Magistrates Court. The experience has been enlightening for me, especially in the area of criminal justice. During the first weeks of the externship, we were able to attend several court sessions and this exposed me to a lot of irregularities in practice in our court systems. Having freshly studied Criminal Procedure I was able to relate the theories learnt in class, that is, what is supposed to be taking place, visa vie what the practice is, that is what is actually done in court. In line with this, we were able to realise that very many accused persons are ignorant of the simpler remedies that even they can employ to the end of achieving justice for themselves. These include selfrepresentation and knowledge of the bail application. It is on this note that my team has undertaken to help raise awareness on bail applications for our project. I also learned to use the Electronic Court Case Management Information System (ECMIS), which is the electronic way of filing cases and management of court information being used in the Ugandan court system now. This is an upgrade of the manual system and it is surely a great improvement in the judicial arena of this country. All in all, the externship has been a great experience for my team and I, and we look forward to executing our project, with the hope that it will impact many lives in this country.'

\*Susanne Kaguta: My name is Susanne Kaguta, and my place of externship has been the Luzira Group of Prisons. This is a description of my experience in my own words. During my time at Luzira, I was given an opportunity to give legal advice on issues of bail, plea bargain, and self-representation. By doing this, I experienced a bit of what it is like to have clients and how to put all I've learned during my three years of study into the practical area. I got to understand the different prisons within the group of prisons, which include Kampala Remand, Murchison Bay Prison, Upper Maximum Facility, and Luzira Women's Prison. I also learned the different dynamics in each of these prisons, especially when it came to differentiating the Upper Maximum Facility from the rest of

the prisons. There, we were not even allowed to speak to any of the inmates. We drew questions from our observations, and the officers tried to answer all the questions. One of the most important things I picked from my time there was how much the system of public defenders is overwhelmed. The inmates on remand are very many in comparison to the number of public defenders available, and this ratio has caused a big lag in the trial of every accused person. I appreciated the legal aid clinics within the prisons that have assisted the inmates with issues of bail applications, file tracing, educating inmates on conduct during trial, among other things. I worked with an amazing team of 9 people who brought their best from day one. I am also grateful for the supervisors who made this experience an amazing one through the guidance we received and to PILAC for the opportunity. Since we were not allowed to take any photos around the Prisons premises, below is one taken during transportation from the Prisons.

Julius says, 'I recently participated in the 9th CLE Moot Competition where Dalton Kisuule, Jamada Kalinda Musa, Stella Nakalema & my team presented an Amicus Curiae application before Hon. Justice Geoffrey Kiryabwire, Hon. Justice Florence Nakacwa & Justice Dr. Singiza Douglas.

The application presented on 20th April via the High Court of Uganda dealt with Fiscal Policy, Economic Justice and Human Rights. It was a great opportunity to understand & apply the legal principles concerning tax justice. It highlighted the intersection of law and socio-economic rights, and the importance of upholding human rights in matters related to taxation. This experience has taught me the importance of research, collaboration, and legal advocacy. I'm grateful for this opportunity and look forward to continuing buttressing my knowledge in promoting fairness and equality in fiscal policies'.

### 2.15 Review of the LLM Programme

A stakeholders meeting to review the curriculum of the LLM programme was held on the 27th June 2023. In her remarks, the Deputy Principal, Dr. Zahara Nampewo delivered welcome remarks to the stakeholder fraternity and staff members of the School of Law and acknowledged the presence of the Director Quality Assurance Directorate of Makerere University and the Senior Higher Education Officer from National Council for Higher Education (NCHE). She Highlighted the purpose of the review of the curriculum of LLM Programme and stakeholder consultation to fulfill the directive of the University and meet the requirement of NCHE. Dr. Nampewo also shared the purpose of this consultative engagement to present undergraduate and postgraduate programs developed and those that have been reviewed to get feedback for final refinement ahead of approval the same. She stressed that the periodical review of the undergraduate and graduate programmes have been on-going and several processes and requirements have been so far met. She also clarified that the review of existing academic programmes and consultative engagements on developed ones are one of the requirements and part of the University regulations across programmes. The feedback from this engagement would make our programmes relevant and focus on the market needs.

The Principal recognized the stakeholders in their various capacities and reiterated that the review processes for LLB and LLM programmes have been on for quite some time; meeting the process requirements and inclusion of the feedback received from such review engagements. The reviews for existing programmes have been moving hand in hand with stakeholder engagements for the new developed programmes including Doctor of Laws (LLD). Cited several stakeholder engagements for new courses that were developed and reviews for existing programmes (LLB and LLM) at Jinja, Entebbe some of which are dated 5 years.

#### 2.16 Graduate Supervision Training Workshop

On the 27th June 2023, a Graduate Supervision Training Workshop was held at SoL. The training was officially opened by the Deputy Principal, Dr. Zahara Nampewo who welcomed the staff and facilitators. She provided an overview of the training and explained that the number of graduate students supervisors at School of Law had grown, as evidenced through the most recent applications for the LLM programme at 204 candidates. She also noted with pleasure that the number of staff eligible to teach at the graduate level had grown from 8 to 25 staff members. It was therefore opportune timing to organise this workshop as part of building capacity of the School and also in furtherance of the university's goal to be research led.

Dr. Zahara also noted that the number of graduate students has equally been increasing from 30-80 LLM students. Participants of the training workshop were given tips on the Pedagogy of Supervision and the need to allow for independent thinking by students.

Highlights from the training:

- a) The aspect of pressure for graduate training and supporting students to complete in time including publication.
- b) Practice of handling graduate students the same way with undergraduate which affects graduate supervision.
- c) Pursuance of research-led agenda of Makerere University requires a shift from experience-based supervision to knowledge-based supervision as teaching and research.

- d) Staff were encouraged to schedule their graduate supervision (with drawn schedule for engagement with students, documenting every engagement, time spent be noted and shared with the with concerned authority).
- e) Encourage the students to engage with materials of the institutions where they carry out research for authenticity and quality assurance purposes. Make students appreciate the value of that material to their thesis.
- f) The need to set up a platform where supervisors share concerns and support each in relation to graduate supervision.
- g) Proposal that doctoral candidates be engaged as teaching assistants to give them more exposure, stimulate them to complete in time and keep them in academic circles.

### 2.17 Online Delivery of our Programmes at SoL

On 10th March 2023, we held an onboard meeting/training about online delivery of our programmes. It was a successful training. Timelines for developing the initial courses were agreed upon.

## 2.18 Field Attachment: Stories from the Field by Clinical Legal Education Students on Internship

Students were out in the field for their internship during the months of July – September 2023. Experience from some of students is shared below.

### Okoth Kenneth' experience as intern at Platform for Labour Action (PLA), Lira District

'My internship experience with Platform for Labour Action (Lira) has taught me the importance of always having mediation and generally the importance of ADR, that aside it has been a good experience especially getting to acquaint myself with employment rights and a deep understanding of the aspect of labour law. This has been mainly through conducting mediations on matters of unfair and unlawful termination plus non payments, most of these cases were settled through mediations at the PLA offices and others with failed mediations were forwarded to the labour officer who has jurisdiction over such employment issues where we represented the clients and successfully concluded some of

the cases while others were referred to the industrial court. I appreciate the opportunity given to me and other colleagues by PILAC under CLE to help people and administer social justice and having an impact in the lives of people that could never afford legal fees or even those that are not aware of alternative settlements of disputes without court.'

John shares a major highlight from the internship, 'during my internship period, I have been privileged to participate in and moderate the final day of the week long Annual Media Fellowship. The Media Fellowship is a unique approach to shape narratives in the media spaces on issues around Sexual Reproductive Health Rights. The Fellowship is designed to build the capacity of media practitioners across the country to be able to enhance their understanding of Sexual and Reproductive Health Rights (SRHR). This was a good learning experience for me to interact with the media practitioners and at the same time sharing knowledge with them on matters of Human Rights in SRHR.'

## 3.2 HURIPEC launched report on Institutional Oversight in Crisis and Management of Uganda's Covid19 Funds

The Human Rights and Peace Centre (HURIPEC), School of Law (SoL), Makerere University launched its report analysing transparency and accountability concerns over the management and oversight of Covid19 funds in Uganda; the report is a result of a one-year research initiative by the centre. Rt. Hon. Thomas Tayebwa, Deputy Speaker of Parliament of Uganda was the Chief Guest at the event held on the 26th April, 2023 at Imperial Royale Hotel, Kampala-Uganda.

Dr. Zahara Nampewo, Deputy Principal-SoL who was the Principal Investigator (PI) of the research presented highlights of the report. She explained that the academic-led research initiative was intended to enhance citizen engagement in promoting transparency and accountability in public expenditure. The initiative was also aimed at stimulating Parliament to oversee the use of public resources in times of crisis. She thanked Open Society, East Africa who funded the research. Some of the report findings include:

- 1) While Uganda has elaborate statutory instruments for oversight, the national response framework for Covid19 dealt with multiple challenges like lack of transparency, ambiguities in procurement to accountability deficits.
- 2) The rising need for transparency and accountability initiatives for Covid19 funds reflects limitations of institutional mechanisms to make government accountable for use and management of resources for health emergencies.
- 3) Uganda government's response to Covid19 has been overshadowed by instances of waste, mismanagement, and blatant corruption.
- 4) Issues like delayed disbursements, unlawful procurement, political use of monetary and other reliefs, diversion of funds, and information deficits have led many districts to deal of pandemics in their own ways in spite of the many guidelines.
- 5) Dr. Nampewo added that lessons from the Covid19 pandemic should be viewed as an opportunity to learn and adopt concrete measures for dealing with health and other related emergencies. Some recommendations from the report include:
- 6) Establish a Comprehensive Crisis Response Framework by government that helps to identify, assess, control risks and review crisis response mechanisms.
- 7) Development of simplified set of procurement guidelines for use during crisis.
- 8) Operationalisation of a Contingencies Fund by government to support a faster and swift response in times of crisis.

Hon. Tayebwa further said, 'Parliament is ready to work with CSOs, researchers and academicians in understanding national issues better. This is because as observers they are in position to offer critical and objective analysis than executive or legislature who are implementers'. He noted that absence of transparency and accountability by government institutions affects Uganda's strategy to reach middle income status. Rt. Hon. Thomas Tayebwa commended HURIPEC and School of Law for the work that they do in protecting human rights of the people. Hon. Tayebwa who is an alumnus of SoL expressed his happiness to be back and excited to receive the recommendations of the report. The Deputy Speaker applauded the groundbreaking work and noted that this particular report is important because it is a useful contribution when Parliament reviews the Auditor General's forensic audit of Covid19 expenditure.

#### 3.3 Book on Militarization and Development in Uganda Launched

A book titled "Militarizing More to Develop Faster?: Uganda's Difficult Choices on Governance, Human Rights and the Economy" was launched on 22nd November 2023 in Copenhagen, Denmark. The book is edited by Sylvie Namwase, Ronald Naluwairo, Zahara Nampewo, and Ole Wæver.

The book is the product of a 4 years' research collaboration between the Human Rights and Peace Centre (HURIPEC), School of Law (SoL) at Makerere University and Centre for Resolution of International Conflicts (CRIC), Department of Political Science, at the University of Copenhagen, Denmark funded by DANIDA.

The book is the first comprehensive analysis of militarisation's permeation and consolidation within Uganda's economy and society. It details the loss of livelihoods, weakened civilian institutions, human rights violations, and widened patrimonial networks among other outcomes of deploying Uganda's military to the country's key development sectors such as fisheries, agriculture, land, and mineral resources. The book is published by The African Studies Bookstore (www. africanbook.shop) and can be ordered online.

#### 3.4 New Initiative: The Makerere Law Review (MLR)

During the reporting period, all the departments at SoL resolved to start the Makerere Law Review (MLR) to support the wider visibility of Makerere University and its relevance to society. It will be a multi-disciplinary legal journal aimed at providing an avenue for both academic staff, post-graduate students at Makerere University as well as practitioners and policy makers to publish their groundbreaking work to inform contemporary global and national issues. The MLR will incorporate both empirical and theoretical research. The following is the leadership of MLR Editorial Board.

#### 3.5 Research Grants and MoUs

#### **HURIPEC wins Research Grant with Partners**

Dr. Sylvie Namwase, Lecturer - SoL and Dr. Zahara Nampewo, Senior Lecturer and Deputy Principal – SoL have been successful in winning a major grant, which will involve a collaboration with the University of Copenhagen (Denmark) and St. Augustine University, Tanzania. The project is titled: 'Charcoal conflict in climate change's decarbonization dilemmas: Knots of livelihood, nutrition, communities, gender, migration and energy in East Africa'. The total grant amount for the entire 5-year project is about 10,399,621 Danish Kroner, estimated USD 1.5m. 3,082,584 Danish Kroner, estimated USD 450,000 is to be expended by activities and work on the Ugandan side of the project over the next 5 years. The grant will support one LLD in Uganda, one PhD in Tanzania, 2 Postdocs from Denmark, 1 Postdoc in Uganda and one Postdoc from Tanzania.

#### Dr. Dan Ngabirano wins research grant

In November 2023 - the HOD, Dr. Dan Ngabirano won a research grant from the International Centre for Tax and Development (ICTS) which is based at the Institute for Development Studies (IDS), University of Sussex, UK. As part of this grant he will develop a working paper on the role of tax instruments in combating the single use plastic waste pollution problem in Uganda.

#### **ELC signs a Memo with Wildlife Conservation Society (WCS)**

In June 2023, Environmental Law Centre (ELC) signed a Memorandum of Understanding with the Wildlife Conservation Society (WCS), a reputable and one of the oldest conservation organisations in Uganda. WCS is also currently a USAID implementing partner under the Uganda Combating Wildlife Crime Activity.

Pursuant to the MOU, the Environmental Law Centre will organize a students moot court competition and develop a training manual for judicial officers on wildlife crime. The moot activities are designed to expose law students to contemporary wildlife crime challenges and to prepare them for a career in this area.

#### 3.6 PILAC Research Report launched

Public Interest Law Clinic (PILAC), SoL released a research report titled: Transforming Legal Education by Promoting Experiential Learning and Enhancing Access to Justice for Vulnerable Groups: A Pilot Project Research Report. The research project that produced the report was funded by the Government of Uganda through the Makerere University Research and Innovation Fund (MakRIF). Professor Christopher Mbazira was the Principal Investigator with Dr. Patricia Atim and Dr. Diana Ahumuza as Coinvestigators. The aim of the Project was to enhance the transformation of legal education by using practical teaching methodologies to promote access to justice for all. The overall objective was to use the experiences of PILAC to determine the impact that selected clinical methods have had on students and the benefits that accrue to persons and communities that are targeted by the clinical activities. To realise the objective, the Project set out to implement the following activities: Establishment of a Legal Call Center, Court Annexed Mentorship, Juvenile Justice Support, Support to the Local Council Courts, and Research on the pilot activities.

#### 3.7 Makerere Law Journal Breakfast Meeting

The SoL organized a breakfast meeting geared towards facilitating students with skills of becoming successful writers. Dr. Busingye Kabumba, Director HURIPEC attended on behalf of the School. During the meeting, students presented their research topics, and were also allocated supervisors to help guide them during their research journey. The Makerere Law Journal was founded on 11 November, 1971 as a publication of the Makerere Law Society, and intended as a medium for discourse on the "immense problems of Law". The Journal is manned by students of law and is independent of the SoL administration. Submissions are reviewed, edited and published by the student editors who are specifically selected, trained and equipped with the requisite skills. Through an intense editorial process, they work with authors to edit a submissions until they are ready for publication.

The project activities are further expected to deepen the SoL's engagement with members of the bench/judiciary, particularly on the role of courts in combating wildlife crime.

#### 3.8 HURIPECTalks Podcast

HURIPECTalks, a podcast hosted by HURIPEC was launched in November 2023. The podcast explores various issues shaping Uganda today and offers a platform where academics at the School of Law and beyond can share their research and reflections on a multitude of topics. This first HURIPECTalks series was on law, militarisation, peace and development defined militarism and militarisation and explored how these phenomena have manifested throughout Uganda's history and present. It examined how militarism and militarisation are impacting rule of law, policy and politics as well as the economy and society, and how they are shaping gender relations, youth expressions and aspirations. The series also unpacked theories of Pan Africanism and decolonisation in relation to militarisation and militarism, and how they influence peace in Uganda and in the broader African context. The different episodes in the series suggested ways in which Uganda can balance the role of the military in operations other than war, such as development and security roles, while preserving democratic agendas and aspirations towards inclusivity, balanced civil military relations and sustainable peace in Uganda



### **Community Outreach**

SoL endeavours to undertake community outreach as one way to take the university to the population in support of research uptake and knowledge transfer for society transformation. Key activities of community outreach accomplished during the reporting period are presented here.

#### 4.1 RLP Training of University Staff on Refugee rights and dynamics

The Refugee Law Project (RLP), a community outreach programme of the SoL, RLP empowers asylum seekers, refugees, deportees, IDPs and hosts communities to enjoy their human rights and lead dignified lives. From 21-22 February 2023 at the Golf Course Hotel in Kampala, the Refugee Law Project held a Training University Staff on Refugee Rights and Dynamics involved in Access to Higher Education for Refugees. This training focused on identifying the gaps, opportunities and generate collective actions for tackling gaps in access to Higher education for refugees in Ugandan Universities.

#### 4.2 Taking the University to the People: Capacity Building Engagements

On 10<sup>th</sup> March 2023, the SoL through PILAC conducted a training of police officers on: Promoting Disability Rights through the Police. The training was hosted at the Police Headquarters in Naguru, Kampala. Under our Administrative Officers' Law Short Course, we have continued to train several officers across the country.

#### 4.3 Legal Aid and Medical Camp

On 2nd and 3rd March 2023, Makerere Law Students in partnership with PILAC, the Students' Guild and Makerere University Hospital organized a legal aid and medical camp for not only students and staff of Makerere University but also for the general public.

## 4.4 Stakeholders at the 10th Annual National Conference on Economic, Social & Cultural Rights call for government intervention to control rising education costs

Stakeholders at the 10th edition of the national conference on economic, social and cultural rights called on government to intervene in controlling the rising education costs in Uganda. The conference themed, 'Human Capital Development: The cost of Education in the era of the National Development Plan (NDP III)' was held on the 14th September 2023 at the Makerere University. The conference was organised by Makerere University School of Law (SoL) Public Interest Law Clinic (PILAC) in partnership with Initiative for Social and Economic Rights (ISER), Uganda Consortium on Corporate Accountability (UCCA) and Network of Public Interest Lawyers (NETPIL).

The conference continued through the day with panel discussions and presentations, some the issues raised included:

- Although it's being cited that the education sector picks a huge chunk of the human capital development budget, if you critically look into the attendant expenditures, you'll notice a lot of wastage
- All hope is not lost. The government is discussing withdrawing funding from Government aided schools that are charging school fees comparable to private forprofit schools to boost public schools
- The ranking of schools according to performance in will end this year. Under the new curriculum, we are looking at the competence of the learner not UNEB ranking
- Even with a liberalized economy, if cost is not regulated, it will propagate inequalities. The question arose of regulators as actors in the same field. You can't be an education government official & own private schools
- School fees regulation is a question of equity. Privilege hates equity. When we are privileged we forget about equity' Ms. Ruth Ssekindi, Uganda Human Rights Education
- It's disturbing that science teachers who are paid the most are the ones that don't

- show up at work the most. They have frustrated the clock-in system'
- We can't leave provision of education to the private sector. We need to protect the
  poor. Government shouldn't leave the cost of education to be determined by the
  private sector regulation is needed.
- Government embarked on a new curriculum for which resources & human capital wasn't mobilized
- Government should look into introducing earmarked taxes for education to be paid largely by the rich and wealthy

#### 4.5 14th Annual Probono Day

SoL students and legal aid unit under PILAC attended the 14th Annual Probono Day held on 1st September, 2023. The day is a community engagement initiative of the Uganda Law Society where lawyers offer advice and free service to the community. - 1. The LLB programme is an intensive course that requires a lot of reading and therefore students interested in the programme should be ready to read.
- 2. The law profession is a continuous reading profession, even when you are a judge, you are always reading to back up your judgments since the law is always changing, lawyers are always reading so you have to be ready to read hard, put in hard work
- 3. The two main avenues one can enroll on LLB is either thru direct-entry scheme (after A 'Level) or mature-entry scheme (those who have completed other study programmes).
- 4. All applicants for the programmes have to sit and pass the preentry exam before admission. After completing LLB, students undertake the bar at Law Development Centre (LDC) and then apply to be admitted to the bar before practicing as an advocate

#### 5.3 Principal's Meeting with SoL Student Leaders





The dialogue attracted participants attending physically and virtually ranging from law students, lawyers, religious leaders, civil society, international partners—and media among others. Some of the issues arising from the discussion included: respect for human rights, religion and the law and challenges posed by the Act on privacy. At the event, it was agreed that another dialogue will be organised at a later date to continue with discussions around Anti-Homosexuality Act,2023.

Hon. Basalirwa, the mover of the Anti-Homosexuality Bill, 2023 gave a brief background of the bill, citing the recruitment of children into homosexuality, financing, and public outcry about LGBTQ as some of the reasons behind the bill. When asked about the criminalisation of homosexuality, he said that it is not a new phenomenon and that colonialists introduced anti-sodomy law in Uganda citing section 145 of the Penal Code.

On the other hand, Dr. Jjuuko, stated that the spirit behind the law is unconstitutional and vague. He cited section 29(1) of the Constitution that provides for freedom of expression and association, noting that the criminalization of homosexuality would limit the freedom of expression of individuals if passed into law. Jjuuko also noted that the Act replicates existing laws that provide for the protection of all people against rape, defilement, and other forms of sexual violence. According to him, there is a need to implement these laws to deal with offenders. He also emphasized the need to respect, uphold and promote the rights and freedoms of individuals and groups enshrined in the Constitution.




#### **5.10 Students Sports Gala**

## 5.11 2nd Annual Nsibirwa Public Lecture: Makubuya calls for Decolonisation of our Systems



The 2nd Nsibirwa Annual Public Lecture themed 'Situating the Role and Relevance of Cultural Institutions in Modern Uganda' was held on 9th November 2023 at Makerere University. The annual public lecture hosted by Makerere University commemorates Martin Luther Nsibirwa, a two time Katikiro of Buganda, 1929-1941 and July - September1945. Katikiro Nsibirwa is remembered for having assented the bill which enabled the Colonial Government to take possession of the land where Makerere University Main Campus stands today. The public lecture was moderated by Dr. Zahara Nampewo, Deputy Principal – SoL.

The distinguished speaker at the lecture was Owekitiibwa Apollo Nelson Makubuya, he is an alumni of Makerere University (School of Law) where he completed his Bachelor of Laws and also served as faculty at the School. He is a founding partner of MMAKS Advocates and a Senior Palace Advisor to Kabaka Ronald Muwenda Mutebi II.

Speaking at the lecture, Professor Barnabas Nawangwe – Vice Chancellor, Makerere University welcomed all to Makerere University and thanked everyone for honoring the invitation to the lecture. He said, 'As far as education in Uganda is concerned, there are two important milestones which we treasure as Makerere University. 1. The letter written by Kabaka Mutesa I to Queen Victoria inviting missionaries to teach his people how to read and write, which was the beginning of modern education in the country. 2. 4th September 1944, when Katikiro Nsibirwa signed the document allowing the colonial government to take possession of Makerere land which many had feared.'

Owekitiibwa Makubuya thanked the University for organising the lecture in recognition of Katikiro Nsibirwa's leadership in laying the foundation of Makerere University which has played a great role in nurturing many in Uganda and globally. He noted that Nsibirwa was self-educated, with no formal education and he achieved a lot. Makubuya called for decolonisation of our systems like naming our landmarks after Ugandans rather than colonial generals.

Using Buganda as a case study and what it has accomplished since cultural institutions were restored 30 years ago, Owekitiibwa Makubuya argued these institutions have a is role to play in modern Uganda. He posed 4 questions to the audience and Uganda as nation for considering in determining the position of cultural institutions: Do they provide solutions to service delivery?, Do they have dynamic adaptation to the new times?, Can these institutions blend both modern and traditional issues?

#### 5.12 iGA Donated Furniture to School of Law

#### 6.1 New Coordinator for the Administrative Officers' Law Short Course

Dr. Patricia Atim P'Odong was appointed New Coordinator of the Administrative Officers Law Short Course (AOLSC) offered at the School of Law (SoL), Makerere University. Ms. Atim P'Odong replaced Dr. Kakungulu-Mayambala who had coordinated the course for 8years.

The Administrative Officers Law Short-course started in 2009 as a collaborative initiative between the then Faculty of Law and the Department of Distance Education (DDE). In 2010, the School of Law Board began conducting the course independent of the DDE. In September 2011, SoL: AOLSC was endorsed by the President's Office through the Permanent Secretary of the Ministry of Public Service as a requirement for entry, promotion and confirmation of Administrative Officers. Currently, SoL partners with districts to offer the course to their officers. The course is 2months with a minimum requirement of an A' Level Certificate or its equivalent.

#### 6.2 New Director at Refugee Law Project

Dr. Ojara De-Saxone Pius was appointed new Director of the Refugee Law Project (RLP) effective 1<sup>st</sup> April, 2023. Dr. Ojara replaced Dr. Christopher Gerald Dolan who left in 2022. The RLP is a community outreach project of the School of Law, Makerere University. The project empowers asylum seekers, refugees, deportees, IDPs and hosts communities to enjoy their human rights and lead dignified lives. The project is mandated to 1) Promote the protection, well-being and dignity of forced migrants and their hosts; 2) Empower forced migrants, communities and all associated actors to challenge and combat injustices in policy, law and practice; 3) Influence national and international debate on matters of forced migration, justice and peace and 4) Serve as a resource for forced migrants and relevant actors.

The Africa Peer Review Mechanism was launched in 2003 as a key component of the New Partnership for Africa's Development (NEPAD) of the African Union to enable voluntary peer review to assess the quality of governance in the participating African Countries. #### **Professor Bakibinga re-appointment on CSAT**

Professor David Justin Bakibinga membership on the External Technical Committee of the Centre for Studies of African Taxation (CSAT) at the International Bureau of Fiscal Documentation (IBFD), Netherlands, has been renewed for 3 years effective from 1st October, 2023.

Launched in 2015, the IBFD Centre for Studies in African Taxation (CSAT) is a think tank dedicated to the study and development of sound tax policies for Africa. Housed within IBFD's Africa Knowledge Group, it is staffed by a team of specialists in the tax systems of all the countries of Africa, and supported by an extensive network of local country experts.

CSAT's activities include the following:

- the provision of research on pertinent tax policy issues in Africa, in the form of research briefings, working papers, and books;
- the delivery of capacity development services (including training and research services) for African government departments, such as revenue authorities and ministries of finance;
- hosting conferences, workshops, and other events, on tax policy issues germane to Africa. (CSAT is the organiser of the renowned annual Africa Tax Symposium);
- collaboration with partner organisations within Africa in providing research and training services, and hosting events centered on African tax policy issues;
- provision of support for academic activities of benefit to Africa. These include the CSAT Fellowship Programme; scholarship awards for post-graduate programmes; and delivery of tax lectures for African academic institutions.

#### **Award of Honorary Doctor of Laws (Honoris Causa)**

SoL nominated Justice Fredrick Egonda-Ntende and Her Excellency, Hon Betty Bigombe for the award of a Honorary Doctor of Laws (Honoris Causa) of Makerere University for thier distinguished service to Uganda and the world at large. ## **Challenges & Future Plans**

#### 8.1 Major Challenges and Needs

- i) Inadequate budget especially for students' extra-curricular activities.
- ii) Public pressure to increase the number of students admitted on the LLB programme.
- iii) Need for more academic staff especially at senior ranks.
- iv) Funding for repair and renovation of the part of the old building that was preserved.
- v) Funding to adequately furnish the School of Law building.

#### 8.2 Future Plans

- i) Increase number of graduate students in line with Makerere University' strategy to become a research-led institution. This is however dependent on the recruitment of more teaching staff.
- ii) Increase and strengthen partnerships with like-minded institutions at regional and international level.
- iii) Revamp the School of Law Alumni Association.
- iv) Develop at least one more specialized Master of Laws degree programme in the next three years, this will also depend on recruitment of more teaching staff.
- v) Develop at least two more tailor-made short courses as part of the School's community outreach programme.
- vi) Increase our policy and legal engagements with different Ministries, Departments and Agencies as well as other stakeholders on emerging topical issues that fall within our disciplinary mandate.
